### **How to Enter:**

1. There is one (1) way to enter the Promotion.
2. Beginning Monday, March 2, 2020 at 9:00 AM ET through (a) Saturday, March 21, 2020 at 6:30 PM ET at Sarnia and Clinton or (b) Saturday, March 28, 2020 at 6:30PM ET at all other Participating Facilities, all MCR Members are eligible to earn Qualified Entries into the Qualifying Draws by playing any Slot Machine or Table Game with their MCR card inserted correctly.
  - One-dollar (\$1.00 CAD) in theoretical win = one (1) Qualified Entry
  - Theoretical win varies and is dependent on each individual game played
3. No Qualified Entries will be earned from 6:30 PM ET – 10:00 PM ET on Qualifying Draw Dates within the Promotion Period to allow the Electronic Quick Draw (EQD) process to take place.
4. There is no individual limit to the number of Qualified Entries a Qualified Entrant may receive. However, a Qualified Entrant may win a maximum of one (1) Qualifying Draw Prize per Promotional Period, per Participating Facility in accordance with these Promotion Terms.
5. NO PURCHASE NECESSARY – See the “No Purchase Necessary” section below.
6. The overall limit for the electronic ballot drum is 999,999,999. Any Qualified Entries earned or received after this total is reached for a single draw would be deemed ineligible.
7. Qualified Entries need to be separately activated for each Qualifying Draw by having one (1) Qualified Visit within the Qualification Period in order to be eligible to win a Qualifying Draw Prize. The activation process is detailed in the “Activating Qualified Entries” section below.

8. Qualified Entries will accumulate throughout the entire Promotional Period and the electronic ballot drum will be emptied at each Participating Facility following the last Qualifying Draw for such Participating Facility during the Promotion Period.

**Activating Qualified Entries:**

11. On Qualifying Draw Dates, all Qualified Entrants who have participated in the Winning Wheels Promotion at a Participating Facility will be afforded the opportunity to activate all Qualified Entries earned at that Participating Facility that have accumulated throughout the entire Promotion Period for the Qualifying Draws by inserting their MCR card into any Slot Machine or Table Game, and registering a minimum \$0.01 of carded play within the Qualification Period.
12. The Qualification Period for each Qualifying Draw will be open from 5:00 PM ET – 7:00 PM ET on each Qualifying Draw Date as shown in Draw Details chart below.

13. Any Qualified Entry that is not activated during the Qualification Period will not be considered as part of the Qualifying Draw and will not be eligible to be selected to win a Qualifying Draw Prize.

**MCR Electronic Quick Draw Procedure:**

14. On each Qualifying Draw Date within the Promotion Period, the electronic ballot drum will close from 6:30 PM ET – 10:00 PM ET to allow the draw process to take place.
15. Qualified Entrants must activate all their Qualified Entries in accordance with these Promotion Terms.
16. At each Participating Facility, one (1) Guest Services employee or site designate (the “Drawer”) will conduct the Qualifying Draw following Gateway's Electronic Quick Draw procedures.
17. Qualified Drawn Entrants will be selected from the activated Qualified Entries.
18. The Drawer will announce over the Participating Facility’s public announcement system the first name, last initial, and MCR Member number of the Qualified Drawn Entrant immediately after the Qualifying Draw.
19. All activated and non-activated Qualified Entries will accumulate throughout the Qualifying Promotional Period and will not be removed from the electronic ballot drum until after the Participating Facility’s final Qualifying Draw has taken place and all Qualifying Draw Prizes have been awarded.

**How to Claim a Qualifying Draw Prize:**

20. Winners of all Qualifying Draws must be present within the Participating Facility to claim the Qualifying Draw Prize. Qualified Drawn Entrants selected will have fifteen (15) minutes to present themselves to a Gateway employee at the designated prize claim area to claim the Qualifying Draw Prize.

21. Before the Qualifying Draw Prize will be issued to the Qualified Drawn Entrant, the Qualified Drawn Entrant must present valid government-issued photo identification to Gateway verifying their identity.
  - If the Qualified Drawn Entrants is unable to present identification at the time of the Qualifying Draw, the Qualified Drawn Entrant may verify their account by correctly answering the following account related information: address, phone number and date of birth.
  - If the Qualified Drawn Entrant correctly verifies their account information, the Qualifying Draw Prize can be considered claimed, but will not be awarded until the Qualified Drawn Entrant returns with valid government-issued photo identification. All Qualified Drawn Entrants who claim a Prize using this method must return to the site with valid government-issued photo identification within forty-eight (48) hours or the Prize will be forfeited.
  - Qualified Drawn Entrants will be required to complete the applicable prize acknowledgment and/or release forms in the presence of one (1) Gateway employee.
22. If the Qualified Drawn Entrant does not present themselves to a Gateway employee within fifteen (15) minutes of the Qualifying Draw, the Qualified Drawn Entrant will be disqualified, and the Drawer will select an alternate Qualified Drawn Entrant. Qualifying Draws will continue until all Qualifying Draw Prizes are awarded in accordance with these Promotion Terms.
23. **March 28, 2020 Qualifying Draws only** - If the Qualified Drawn Entrant does not present themselves to a Gateway employee within fifteen (15) minutes of the Qualifying Draw, the Qualified Drawn Entrant will be disqualified, and no alternate Qualified Drawn Entrants will be drawn.
24. If, at the time of the Qualifying Draw and after the announcement of the Qualified Drawn Entrant is made, the site is at legal capacity that prevents a potential Qualified Drawn Entrant from entering the building, the Qualified Drawn Entrant must declare themselves the winner to any Gateway employee within the allotted claiming period but does not have to present themselves to the Guest Services desk or draw area within the claiming period. Once declared, the potential winner will be vetted by a Guest Services representative to validate the winning Qualified Entry.
25. Each Qualified Drawn Entrant will receive one (1) Grand Prize Draw Invitation for the Grand Prize Draw being held on March 28, 2020 at the same Participating Facility at which the Qualified Drawn Entrant was drawn, with the following exceptions:
  - Qualified Drawn Entrants drawn at Sarnia will attend the Grand Prize Draw at Point Edward;

  - Qualified Drawn Entrants drawn at Clinton will attend the Grand Prize Draw at Hanover.
26. Grand Prize Draw Invitations are not transferable once awarded to the winner and must be accepted as awarded.
27. **Qualified Entrants may qualify for a maximum of one (1) Grand Prize Draw invitation. If a Qualified Entrant is selected as a Qualified Drawn Entrant at more than one (1) Participating Facility, the Qualified Drawn Entrant must select one (1) Participating Facility at which to attend the Grand Prize Draw and must forfeit all other Grand Prize Draw Invitations.**

### **System Malfunction:**

28. In the event of a technical issue with the Quick Draw/EQD system at the time of the Qualifying Draw, the site, the Drawer will continue to attempt to conduct the Qualifying Draw for up to thirty (30) minutes following the draw time. Announcements will be made informing Qualified Entrants that due to technical difficulties; the Qualifying Draw will be delayed for approximately thirty (30) minutes.
29. If after thirty (30) minutes the Quickdraw/EQD system has not restored, sites will advise Qualified Entrants that the Qualifying Draws will take place once the system has been restored and Qualified Entrants are not required to be present to win.
30. Sites will conduct the Qualifying Draws once the system is restored and will contact the Drawn Qualified Entrants via their preferred method of contact, as recorded in the CMP database, once the Qualifying Draws have been completed.

### **No Purchase Necessary:**

31. Qualified Entrants who wish to receive Qualified Entries in the Promotion without purchase must write a short Two Hundred & Fifty (250) word essay stating their favourite place to take a road trip. Upon completion, the Qualified Entrants must bring the completed essay to the Guest Services Desk at the Participating Facility within the Qualification Period on the Qualifying Draw Date. If the essay is complete, a Guest Services Supervisor or above, or site designate, will award five (5) Qualified Entries to the Qualified Entrant and activate the Qualified Entries for the Qualifying Draw by making a manual machine rating of \$.01 cent on the player's MCR account. Limit five (5) Qualified Entries per Promotional Period, per Participating Facility, via this entry method.

### **How to Win a Grand Prize at a Participating Facility:**

32. The Grand Prize Draw at each Participating Facility will be held at 9:00 PM ET on the Grand Prize Draw Date.
33. Each Qualified Drawn Entrant must attend the Grand Prize Draw at the same Participating Facility at which the Qualified Drawn Entrant was drawn, and must register his or her attendance at the Guest Services desk or designated registration area at such Participating Facility between 2:00 PM ET and 8:30 PM ET on the Grand Prize Draw Date.
34. Qualified Drawn Entrants must present their Grand Prize Draw Invitation, along with valid government-issued photo identification and MCR card at the Guest Services desk or designated registration area (as applicable) to be successfully registered for the Grand Prize Draw. These requirements will be strictly enforced.
35. Upon successful registration in accordance with these Promotion Terms, each Qualified Drawn Entrant will receive the following:
  - One (1) Grand Prize Ballot; and
  - One (1) ten-dollar (\$10.00 CDN) Gas Card.
36. Qualified Drawn Entrants must complete their Grand Prize Ballots in full with all required information (including, but not limited to, their first and last names, MCR Member number if applicable, and

telephone number). Information recorded on the Grand Prize Ballots must be legible. Gateway will provide assistance completing the Grand Prize Ballots when requested.

37. Qualified Drawn Entrants must deposit their completed Grand Prize Ballots in the ballot drum located in the prize area prior to 8:55 PM ET on the Grand Prize Draw Date to be eligible to win a Grand Prize.
38. Where Qualified Drawn Entrants drawn from two (2) different Participating Facilities are present at a Grand Prize Draw, there will be two (2) separate ballot drums – one for each Participating Facility's Qualified Drawn Entrants. Each Qualified Drawn Entrant must deposit his or her completed Grand Prize Ballot in the ballot drum for the Participating Facility from which he or she was drawn.
39. All successfully registered Qualified Drawn Entrants must present themselves to the Grand Prize Draw area at the applicable Participating Facility by 8:55 PM ET on the Grand Prize Draw Date. As the Grand Prize Draw area will vary by Participating Facility, details can be found at the Guest Services desk.
40. At 8:55 PM ET on the Grand Prize Draw Date, the Master of Ceremonies and/or Participating Facility representative will officially close the ballot drum to allow the draw process to take place and will announce that Grand Prize Draws will be commencing.
41. At 9:00 PM ET on the Grand Prize Draw Date, the Master of Ceremonies and/or Participating Facility representative will draw the specified number of Qualified Drawn Entrants from the designated ballot drum containing all Grand Prize Ballots, as set out in "Grand Prize Draw Details" below.
42. At Participating Facilities at which Qualified Drawn Entrants from two (2) Participating Facilities are present, the Master of Ceremonies and/or Participating Facility representative will draw Grand Prize Ballots by alternating between the two (2) ballot drums using a 2:1 ratio between Point Edward and Sarnia, respectively, or Hanover and Clinton, respectively, as the case may be.
43. The Master of Ceremonies and/or the Participating Facility Representative will announce over the Participating Facility's public announcement system the first name and last initial of each Grand Prize Winner immediately after the Grand Prize Draw. If any drawn Grand Prize Ballot is illegible, as determined by the Drawer, the Grand Prize Winner will be disqualified, a Grand Prize will not be awarded to such Grand Prize Winner, and the Drawer will select a new Grand Prize Winner.
44. Once selected, a Grand Prize Winner's Grand Prize Ballot will not be re-deposited in the ballot drum for further Grand Prize Draws.
45. Each Grand Prize Winner must present himself or herself to the Master of Ceremonies or the Participating Facility representative (as applicable), within five (5) minutes of the first announcement of his or her name in order to be eligible to receive a Grand Prize.
46. The Grand Prize Draw process will continue until all of the Grand Prize Winners for such Participating Facility have presented themselves at the Grand Prize Draw area.
47. Each Grand Prize Winner will select one (1) envelope in the order in which his or her Grand Prize Ballot was drawn from the ballot drum. Once all Grand Prize Winners have an envelope, they will



wait for the Master of Ceremonies or the Participating Facility representative (as applicable) to count down from five (5) to zero (0), at which time each Grand Prize Winner will open his or her envelope to reveal his or her Grand Prize.

48. The chances of being selected as a Grand Prize Winner are dependant on the number of Qualified Drawn Entrants entered into the Grand Prize Draw at each Participating Facility and will vary by Participating Facility.
49. In the event that a Qualified Drawn Entrant suffers serious illness or injury, or otherwise at the Participating Facility’s discretion, the Qualified Drawn Entrant may designate another person (the “Qualified Drawn Entrant’s Delegate”)to attend the Grand Prize Draw on his or her behalf by completing such documentation as may be required by Gateway. **How to Claim a Grand Prize Drawing Prize:**

51. Except as otherwise set forth in these Promotion Terms, Grand Prize Winners must be present at the Grand Prize Draw area within the applicable Participating Facility in order to claim a Grand Prize.

52. Before a Grand Prize will be issued to the Grand Prize Winner, the Grand Prize Winner must present valid government-issued photo identification to Gateway verifying their identity.
- If the Grand Prize Winner is unable to present identification at the time of the Grand Prize Draw, the Grand Prize Winner may verify their account by correctly answering the following account related information: address, phone number and date of birth.
  - If the Grand Prize Winner correctly verifies their account information, the Grand Prize can be considered claimed, but will not be awarded until the Grand Prize Winner returns with valid government-issued photo identification. Any Grand Prize Winner who claims a Grand Prize using this method must return to the applicable Participating Facility with valid government-issued photo identification within forty-eight (48) hours or the Grand Prize will be forfeited.

All Grand Prize Winners will be required to complete the applicable prize acknowledgment and/or release forms in the presence of one (1) Gateway employee.

53. There will be one (1) Vehicle Prize available to be won at each of: Woodstock, Chatham, Thunder Bay, Sault Ste Marie, and Sudbury. There will be one (1) combined Vehicle Prize available to be won at Point Edward/Sarnia and one (1) combined Vehicle Prize available to be won at Hanover/Clinton.
54. If the Vehicle Prize Winner is an eligible Canadian or American citizen, the Vehicle Prize Winner claiming a Vehicle Prize must elect to receive the Vehicle Prize. Unless otherwise agreed by Gateway in its sole discretion, no cash equivalent or prize substitutions will be offered in this Promotion.
55. The Vehicle Prize Winner must accept the Vehicle Prize as is, subject to the availability of the Vehicle Prize in the dealership inventory. Any upgrades, changes, or special request fees regarding the Vehicle Prize are the sole responsibility of the Vehicle Prize Winner and any associated fees will be paid by the Vehicle Prize Winner to the dealership.
56. If the Vehicle Prize is unavailable in the dealership inventory on the Grand Prize Draw Date, the Vehicle Prize may be substituted with a vehicle of an equal value through the dealership. The Vehicle Prize or any substituted vehicle may be ordered through the dealership and delivery will be scheduled in accordance with the availability of the Vehicle Prize or any substituted vehicle.
57. The Vehicle Prize Winner for a Vehicle Prize will be required to sign the applicable prize acknowledgment and/or release forms.
58. Vehicle Prize Winners must contact the dealership directly within fourteen (14) days of the Grand Prize Draw Date to arrange for transfer of ownership of the Vehicle to the Vehicle Prize Winner. The Vehicle Prize Winner will be solely responsible to provide all applicable identification and documentation required by the dealership, in the dealership's determination, to transfer ownership of the Vehicle Prize.
